- Be an active member, in good standing, of the Booster Club.
- Attend WFC Board of Director meetings, generally held every other Monday, from 6:30 to approximately 8:00 PM. In accordance with the WFC Bylaws, failure to attend three (3) consecutive meetings could result in removal from the Board.
